Principles for User Content

which govern the basic rules and the permitted nature of information and data put on the Server by the Users

(part of the General Terms and Conditions for services provided by Vienna Point a.s. (among others) at the website uphistory.com)

1. General Provisions

- 1.1. These Principles for User Content represent an integrals and binding part of the Conditions.
- 1.2. The terms and definitions written with a capital letter used, but not defined in these Principles of User Content, have the meaning assigned to them in the General Conditions.

2. Principles of User Content

- 2.1. The User has the following rights and obligations in relation to the User Content:
 - 2.1.1.The User is entitled to choose any title for the Uploaded File. The title of the Uploaded File must not contain vulgarisms or expressions which are in contradiction to articles [2.2.] and/or [2.3.] of these Conditions for User Content. In case the title will not comply to the conditions stated in the just mentioned clause, or if it would be in any way contentwise or graphic-wise inappropriate, the Provider claims the right to change the title or to delete any Uploaded File with an inappropriate title from the Server, or to limit user access to this particular File.
 - 2.1.2. When uploading a file to the Server, the User shall decide whether the Uploaded File will be shared publicly or if access to this Uploaded File will be restricted.
 - 2.1.3. The user is oblige to refrain from uploading erotic and/or pornographic user content on the server. In case that user uploads, in contrary with this prohibition, erotic and/or pornographic user content on the server, the user content may be removed or locked up.
 - 2.1.4. Only registered users can delete their uploaded files.
 - 2.1.5. The User may make the content of the Uploaded File inaccessible for other Users by labeling the file as private. By uploading the Uploaded File, the User shall not violate the rules set forth in these Principles for User Content.
- 2.2. The upload of User Content onto the Server, mainly in relation to the name and content of the Uploaded File uploaded by the User onto the Server of the Provider, the texts of the comments and/or the content of private messages, shall not be in breach of legal regulations and of the Conditions, and it shall not be in violation of the rights and legally protected interests of the Provider, of other Users and of third parties. By uploading Uploaded Files onto the Server, the User shall not:
 - 2.2.1.violate copyright and related rights, rights to trademarks, business name, protected appellation of origin or industrial rights;
 - 2.2.2.incite to hatred against a group of people or towards restricting their rights and liberties, or defame nationality, ethnic origin, race and/or belief;
 - 2.2.3.support or promote a movement that demonstrably aims at suppressing the right and liberties of man;
 - 2.2.4.incite to committing a crime, to a mass inobservance of a significant obligation imposed by law or approve of a crime;
 - 2.2.5.depict torture of animals;
 - 2.2.6.state untruthful information about a third person which could to a significant extent be a risk to his/her dignity, good name or reputation, harm them in their work, disrupt their family relations or cause him/her severe harm;
 - 2.2.7.promote in any manner whatsoever a business entity that is a competitor to the Provider or upload content that could harm the good name of the Provider;
 - 2.2.8.violate the obligation of confidentiality imposed by law or violate or endanger the business secret of a third party;

- 2.2.9.spread inappropriate or harmful files and/or information, in particular viruses, Trojan horses, rootkits, backdoors, spyware, adware or any other malware;
- 2.2.10. spread files and/or information that represents direct or indirect link to content that does not conform to the requirements of these Principles for User Content, in particular URL links, URI links, trackers, torrents and other links.
- 2.3. The User shall not upload onto the Server files which:
 - 2.3.1.would give access to persons under 18 years of age to any pornographic work, or other content which could disturb the healthy development or moral education of minors;
 - 2.3.2.contain pornographic works that display or otherwise involve a child or a person who appears to be a child;
 - 2.3.3.contain pornographic works which display violence or disrespect to humans, or which describe, depict or otherwise represent sexual intercourse with an animal.
- 2.4. The User shall not behave on the Server or otherwise abuse the Service in a manner which would be in violation of legal regulations, these Conditions, or with the rights and legally protected interests of the Provider, other Users or third parties, e.g. enter or send in any manner unsolicited business messages ("spam") or upload such User Content as would limit the functionality of the Service or as would make the use of the Service more difficult for other Users.

3. Statement regarding child pornography

In accordance with 2.3 of the Principles for User Content, the Provider does not and will not tolerate child pornography uploaded onto the Server in any manner whatsoever. If the Provider shall become aware of the presence on the Server of child pornography, he shall take such immediate steps as may be requested of him towards the removal or making inaccessible of child pornography on the Server.

The Provider explicitly reserves the right to employ against the User who uploaded onto the Server child pornography all and any legal means, including, but not limited to, the rights arising from these Conditions and/or the cooperation of law enforcement agencies with the aim of identifying the persons involved in the spreading of child pornography.
